Sloughhouse Solar Farm

The Board of Supervisors deliberated on the proposed Sloughhouse Solar Farm at Dillard and Meiss Roads at our January 12 public hearing. My colleagues and I took action to certify the Environmental Impact Report which concluded that the project would not result in significant and unavoidable impacts with implementation of the

recommended mitigation measures. This action cleared the project to move forward.

It was not something we undertook lightly.

Our rural-urban connections are a delicate balancing act between the disparate needs of protecting our rural communities, encouraging denser development in our urban and suburban areas, and diligently supporting the economic viability of our farms, ranches, orchards and vineyards in Sacramento County – all while remaining mindful of the critical environmental benefits associated with realizing measurable progress on our climate action goals.

These conversations are challenging but agricultural viability is becoming increasingly reliant on ancillary revenue sources; whether through benefits of ag tourism on farm stays, wineries, breweries and other event centers; local farm to market opportunities such as farmers markets, farm stands and produce subscription boxes; or, in cases like this, mitigation prompting conservation easements that help other productive land stay viable.

During the Board of Supervisors hearing, Stan Van Vleck of Van Vleck Ranch commented, “In 2016, the Board of Supervisors approved us working in partnership to try to preserve our operations as one of the longest-lived ag operations in the state, dating back to before Abraham Lincoln started as President. We plan on being here for a lot longer by working to keep our ranch in business in perpetuity.” I assure you the Van Vleck Ranch is not the only ag property in our county that we need to remain viable. There are many, many others.

Sacramento County’s farms and ranches generated \$602.7 million in 2022, reflecting 5% growth over the prior year and largely coming from the communities along the southern and eastern boundaries of our county. But family farmers continue to struggle, and future generations of farmers will face even greater challenges to their productivity and viability when factoring in the increasing costs of land, water, equipment, labor and other operational costs, and the risks of extreme weather incidents like heat waves and floods from atmospheric rivers.

Solar energy is a conditionally permissible land use in Ag-20 zoning areas with an appropriate use permit. Ensuring our rural-urban connections are successful for impacted residents surely includes listening to neighbors and community members, incorporating robust landscape buffers for visual benefits and ultimately preserving important farmland.

As we move toward carbon neutrality goals in Sacramento County, greater reliance will be placed on renewable energy sources and electrifying our economy, including moving our household appliances away from natural gas and our vehicles toward renewable energy. I’m supportive of a fiscally prudent approach to the implementation of these measures while ensuring the mutual economic benefit to

keeping our farmers and ranchers in business, with the addition of community-friendly solar projects.


